Please remember, it is required to post your ROC number anywhere any work is being performed. It is also required to be on all advertising, including business cards, letterheads, pens, flyers, newspaper ads, signs, work vehicles, bookmarks, internet sites, T-shirts, mall displays, newspaper, television, radio etc. This is by statute §32-1124.B.

If you are not licensed, you are required by statute §32-1121.A14.c to have the words, "not a licensed contractor" on all forms of advertising. If you are not licensed and do not display these words on your advertising, it is a criminal offense.

Please take the time to review your advertising to make sure you are complying with State Law.

If you are a homeowner and do not see an ROC number or the words, "not a licensed contractor", then ask them if they are licensed.

Additionally, you can check the information on our website: <a href="https://www.azroc.gov">www.azroc.gov</a> to confirm their license status. Any complaints or concerns can also be filed through the website.

# Jeffrey Fleetham appointed as new ROC director

#### **Katie Mayer Electric Times March 2015**

Former consultant, construction industry member and Registrar of Contractors (ROC) investigator Jeffrev Fleetham has been appointed director of the Arizona Registrar of Contractors by Governor Doug Ducey.

In his new role, Fleetham plans to foster communication with trade associations, increase the agency's focus on enforcement of unlicensed entities in areas with heavy renovation activity and provide high quality customer service to the public and licensed contractors.

"Becoming the director of the ROC wasn't just a whim," Fleetham said. "Many in the industry began to notice that there was overregulation of not only this industry, but others, and we began a task of trying to figure out how we can change that...ultimately it came out that I was the guy they came to and I said 'yes.'"

He added, "I did this because it was

a duty." Fleetham said his duty to the construction industry runs deep. He was adopted from an orphanage as a child and

raised in a construction family. His father, a contractor, moved the family from Oregon to Arizona in 1959 and started his own construction company, providing residential and small commercial contracting services. "

As a kid, we always worked for him, so that's the way I was raised," Fleetham said. Although Fleetham grew up in the business, the mid-1970s were a tough time for the industry and he forged his own path in the consumer products industry, where he worked for more than 20 years in high- level sales. The career took him all over the country, but he eventually returned to Arizona and spent seven years as an investigator with the Registrar of Contractors. He also owned a residential project consulting and dispute resolution company.

Fleetham credits his experience in the private sector and background in construc-

tion with giving him a unique perspective that will help him in his leadership role with the ROC.

"Some people in bureaucracies don't have any private sector experience or construction experience," Fleetham said.

Fleetham also believes it's important to participate in trade associations and said it is his "duty" to understand as much as he can in order to "lift the industry up."

"I'm a square peg in a round hole and I'm trying to figure out how I can make things better for the public as well as the licensed contractors," Fleetham said. "Contractors have been treated as a separate class."

Governor Doug Ducey said in a statement that Fleetham has the experience required to carry out the ROC's mission with success.

# Meet our speaker for the April General Membership Meeting: **Cochise County Sheriff Mark Dannels**

Mark J. Dannels "Sheriff for All the People"

On November 6, 2012, Mark J. Dannels was elected by the citizens of Cochise County to serve as their 26th Sheriff.

Sheriff Mark J. Dannels is a 29 year veteran of law enforcement. He holds a Master's Degree in Criminal Justice Management from Aspen University and is a Certified Public Manager from Arizona State University. He has over 3000 hours of law enforcement training in his portfolio. He attended Disney's Leadership and Executive Training programs and is a graduate of the Rural Executive Management Institute. He began his law enforcement career in 1984 after serving a successful tour in the U.S. Army. He progressed through the ranks with the Cochise County Sheriff's Office to the position of Deputy Commander

after working numerous specialty assignments and leadership roles. He was instrumental in the creation of the Southeastern Arizona D.U.I. Task Force and the Special Operations Unit. He was instrumental in proposing and being awarded over 1 million dollars in grant funding to assist the Sheriff's Office. He was appointed by former Arizona Governor Janet Napolitano to the D.U.I. Oversight Commission and later elected to the position of Chairman.

In 2008, he retired from Arizona law enforcement to accept an opportunity to serve as the Police Chief for the City of Coquille in Oregon to build upon his leadership base. During his tenure as police chief, Sheriff Dannels was instrumental in solving a decade old murder case involving a local teenager that help restore community trust. Additionally, he revitalized professionalism and standardization within the department. During Sheriff Dannels' time in Oregon, he volunteered

every 3 months and worked as a reserve deputy sheriff for the Cochise County Sheriff's Office by flying back

to Arizona to fulfill his commitment and required hours. After a successful endeavor as Police Chief, Sheriff Dannels moved back to Arizona in 2011 to rejoin the Cochise County Sheriff's Office to pursue his goal of being sheriff. Sheriff Dannels is a long time member of the Fraternal Order of Police, current member of the International Association of Chiefs of Police (IACP) and serves on several community service groups; San Pedro Kiwanis, Just Kids Inc., CASA, Sierra Vista Elks, the Boys and Girls Club of Sierra Vista, the varsity wrestling coach at Buena High School, and instructs at Wayland Baptist University.

Sheriff Dannels participates in many community outreach programs such as Project Graduation, Sizzle, Stocking Stuffers, Community Haunted House, and Shop with a Cop.

Sheriff Dannels has received numerous awards during his tenure that include the Medal of Valor, National Lifesaving award, American Police Hall of Fame Commendation, Deputy of the Year, MADD Recognition for Outstanding Efforts in Drunk Driving Enforcement, Fraternal Order of Police Member of the Year, Distinguished Service Award, Unit Citation Award, Sheriff's Medal. League of United Latin American Citizens and F.B.I. Community Service Award, National Highway Traffic Safety Administration and Governor's Office of Highway Safety Outstanding Deputy of the Year, Chamber of Commerce Positivity Award, and the Rotary Club Community Service Award.

# Water Wise: Tree Pruning and Care

early March are good months for pruning fruit trees and landscape plants, but do you really know what you are doing?

Pruning is an art and a science. It may look easy but pruning takes practice and a little know-how.

Each year, the Water Wise program sponsors a pruning clinic. This year, on March 14, Bill Cook, Graham County Cooperative Extension horticulturist, will hold a pruning clinic at the UA South campus, 1140 N. Colombo Ave, Sierra Vista, Groth Hall in the Public Meeting Room from 9 to 11 a.m. After a brief overview, he will demonstrate on outside plants, so dress for weather. If you miss the clinic. Water Wise and the Cochise County Master Gardeners have plenty of information to provide upon request or via websites.

When a plant is cut, it causes injury and stress (to the plant and hopefully not you, too). This is why it is important cut correctly so the plant heals quickly. Here are some tips:

Start small, but not too small. Do not cut off branches from newly planted trees. They need all the leaves they can get, and branches make the trunk stronger. After about two or three years, slowly bring up the limbs but do not remove more than a third of the plant each year. This is especially important if pruning has been delayed for years and large limbs need

Whoa, hold that cut! February and to be removed (which is why it is best to begin pruning trees at a young age). Leaves also shade the trunk. If a trunk is suddenly exposed to more sun, wind and cold, it can cause the tissues to split, weakening the tree.

Look for rubbing and crossing branches. These will be the first limbs to remove

Cut in the right place and prune just outside of the bark collar (the wrinkly tissue at the junction of branches or trunk). Without cutting into the bark collar, make a smooth cut and not leave a stub. When pruning twigs, cut the twig at an angle towards a bud so when the bud grows into a twig, the twig will grow in the intended space.

Get rid of the pruning paint, especially the black paint. Plants have a natural ability to heal and do not need paint. Hot sun on black paint can heat up the painted area putting more stress on the plant.

Do not top trees. Repeat. Do not top trees. If a tree has outgrown its space and needs pruning, do not top it. Stubbing the trunk or branch ends creates many small, weakly connected branches. To avoid this problem in the future, choose the right plant for the right place by considering the mature size of the plant and giving it ample room to grow.

Water right. Landscape plants do not like constantly wet soil or shallow watering. Wet soil causes root rot. Shallow watering causes shallow roots leading to instability and shallow roots dry out faster.

Water at the drip line, not at the base of the trunk. Think of the plant as an umbrella. When it rains, it is dry under the tree and soaking wet at the edge of the branches. It is at the edges of the branches, the "drip line", where small roots best absorb water.

Water to the right depth. The majority of plant roots are in the top three feet of soil. Tree roots are about three feet deep, shrubs two feet deep and small plants one foot deep. Water to those depths at each watering and no deeper.

Water about every two weeks or less often for moderate and less water-needy plants, even during the hottest part of the year. Yes, that's right. According to the "plant bible" Sunset Western Garden Book, for moderate and less water thirsty plants (which are a majority of Cochise County landscape plants), watering guidelines recommend every two weeks or less – even in the hottest time of year.

Groundcovers and small flowering plants may need an extra drink in between, but deep and infrequent watering is the best strategy.

Mulch. Put a two to three inch laver of bark or rock over the root zone of plants. This will greatly reduce evaporation of water from the soil and keep water in the soil for plants to use.

With proper pruning, watering and plant care, landscape trees and shrubs can return our investments in them for years to come.

# Person contracting without a license ordered to pay \$135,000 civil penalty

After recent administrative hearings Christopher Lewallen was found to have committed numerous violations of contracting without a license. A person violates state law by (1) advertising to perform services that require a contractor's license, and/or (2) acting in the capacity of a contractor without a license. As a result of these violations, Lewallen was ordered to pay civil penalties totaling \$135,000. These civil penalties are deposited in the State General Fund.

The Registrar of Contractor's investigation found that Lewallen was advertising that his company was able to provide solar power equipment and installation. The 71 contracts from Lewallen's advertising totaled nearly \$2 million dollars

"Homeowners should hire licensed contractors because licensed contractors have documented experience, and possess a license bond to ensure the job is done right," said Jeff Fleetham,

Director of the Arizona Registrar of Contractors.

The Registrar of Contractors advises homeowners to protect themselves by:

- Reviewing the contractor's license record at (http://www.azroc.gov/forms/contractorsearch.html).
- Verifying that the person is an authorized representative of the licensed contractor by calling the contractor's number listed on the ROC license record.
- Asking for written estimates from at least three contractors.

- Requesting a list of references and checking them.
- Making sure the scope of the project, the price, the responsibility to obtain building permits, and any other relevant terms are spelled out in a written contract.
- Never paying in cash, making checks payable to the licensed contractor (not an individual), and not allowing payments to get ahead of the work.
- Avoiding contractors who require large upfront payments.
- Never making a hurried decision.
