## OSHA Resources

### OSHA Top 10 Most Frequently Cited Standards for 2023

OSHA recently released its eagerly awaited annual list of the Top 10 Most Frequently Cited Standards for 2023 (opens in a new tab) at this year's National Safety Council (NSC) Safety Congress &

Expo (opens in a new tab). The OSHA Top 10 List of Most Frequently Cited Standards is so highly anticipated because it provides valuable insights for safety professionals and other health and safety industry stakeholders into OSHA's enforcement activities during the previous year, trends in workplace health and safety risks, and clues as to where employers should focus their efforts to improve compliance and better protect workers.

#### OSHA Top 10 Most Frequently Cited Standards for 2023

Below is the full ranked list of OSHA's Top 10 Safety Violations during FY 2023 ending September 30:

- Fall Protection—General Requirements (1926.501): 7,271 violations
- Hazard Communication (1910.1200): 3,213 violations
- Ladders (1926.1053): 2,978 violations
- Scaffolding (1926.451): 2,859 violations
- Powered Industrial Trucks (1910.178): 2,561 violations
- Lockout/Tagout (1910.147): 2,554 violations
- Respiratory Protection (1910.134): 2,481 violations
- Fall Protection—Training Requirements (1926.503): 2,112 violations
- Personal Protective and Lifesaving Equipment—Eye and Face Protection (1926.102): 2,074 violations
- Machine Guarding (1910.212): 1,644 violations
